bathroom, fetch water and the like. According to the suggestion of Govt. nominee. Saiful Anam she has been paid Rs.500/- for those additional works from the month of November, 2015. She prayed for permanently Rs.500/- per month.

It was resolved in the meeting on the basis of her prayer that Rs. 500/per month will be paid by the college permanently.

Salary payment of Guest and Contractual teachers: The Principal informed the GB that the salary of Guest and Contractual teachers from March to June, 2016 is yet to be paid due to shortage of college fund. He also said about the financial crisis of the college fund as 50% of tuition fees has to be paid to the Govt, and other amount paid by students is not sufficient for various necessary expenditure of the college.

Members were discussing problem of the payment of the Guest and Contractual teachers from different angles, but they could not reached any specific resolution.

In this context the GB resolved that irregular teachers who do not be present or make contact with the college will not be remunerated at all. Teachers who remain absent for approx 50% of their working days will be remunerated half of their salary. Any application or prayer in this regard will be placed at GB meeting as per Principal convenience and may be considered by the GB only.

Regarding Tuhin Kanti Bhandari's long absence and irregularity in his duties, the GB resolved in the meeting of 11.05.2016 that his salary will be stopped from March,2016. If he appealed it will placed in the GB.

- Leaves for Guest and Contractual teachers: After discussion on their leaves it was resolved in the GB meeting that they get CL-7. ML-2and CL-14 and ML-5 respectively.
- In regards of leaves the GB resolved that any staff of this College who may be required in the interest of the college to work during holidays will be entitled to Compensatory Leave for an equal number of days for which he/ she is required to work during the holidays.

There will be no accumulation of such Compensatory leave and it is to be availed within three months from the date of accrual.

- Permission for audits from 2013-2014, 2014-2015 and 2015-2016 financial year along with internal audits for the respective years: The GB gave permission for audits as proposed and stated.
- Formation of different sub-committees: Proposal for formation of different sub-committees placed in the meeting and was discussed. It was resolved in the meeting that the Principal will finalize the committee. রেজল্যুশন / Resolution Adopted

Proceedings of the meeting of the Governing Body of the college held on 18.02.2017 (Saturday) at 11.45 a.m. in Principal's room at college premises, along with resolution are as follows:-Hon'able President of the G.B. Sri Jogaranjan Halder took the chair and presided over the meeting.

Agendum No.1: Confirmation of the proceedings last two GB meetings dtd. 03.01.2017 and 19.1.2017, along with their matter arising if any: They were read and conformed in the meeting dtd.18.02.2017 (Saturday).

Matter arising about the proceedings, if any: There was no mater arisen in the meeting dtd. 03.01.2017.

In the matter arisen regarding meeting 19.1.2017, the Principal stated that the said meeting was postponed due to unavoidable circumstances. He added that most of the Guest and Contractual teachers rashed into his chamber, some of whom falsely accused, threatened him. They ignored his repeated request not to perform such undue and condemnable acts of locking. Then they left the room and locked Principal alone for four hours in his room while he was waiting for other members to come in.

The President called Guest and Contractual teachers and warned them that such condemnable acts of locking the Prinipal by them is not tolerable anyhow. According to CU Statutes commission of such offence involving moral turpitude invites disciplinary action against him/ her whoever commits such offence. For this blameable offence the concerned teachers should beg their pardon to the Principle and they assure that such offence will not reiterate. They abode by his advice.

Agendum No.2: Salary payment of Guest and Contractual teachers and their service: The Principal reported that monthly remuneration of guest and contractual teachers remains due from the month of September, 2016 till date due to very much crunch of college fund. The accountant said that at present from students' tuition fees only one lakh per year will be paid for remunerating the guest and contractual teachers. Because the 50% of tuition fees has to be paid to the Govt. and other amount paid by students is not sufficient for various necessary expenditure of the college so as from the other fund the huge amount will not available to spend for remunerating them. He also added that Rs.38, 000/- per month cannot be provided for the said purpose any more. In this respect the Accountant demonstrated and explained how much fund can be provided for them as an annexure.

It was divulged from above-statement that for a long time regular fund-transfer without GB's approval, proper realisation and Budget internal or statutory Audit texpending the huge amount of teachers' salary was eating into college finance.

The Principal stated that the salary of the said teachers has been paid for August, 2016 from other fund at the advice of President. In discussion it was revealed that previously the issue was discussed in many meetings (vide proceedings of the last meeting dtd. 11.06.2016), but it was not possible to reach a concrete resolution or decision. Then the Principal earnestly requested the members that in this meeting a resolution was required to be taken positively in this regard. The teachers, being not accommodated, will be discontinued for the slack-session from March 2017 to June or July 2017 due to extremely financial scarcity of the college fund. The President stated that due to crunch of fund they would be terminated as stipulated in their appointment letters though their appointment exceeds six months. The college tried to pay their salary without discontinuing them indespite of scarcity of fund. The tenure of the present GB is expiring on 10<sup>th</sup> March,2017. That was the last GB meeting, as he considered, that was why the existing GB did not terminate them. The ensuing GB will take necessary resolution in regard to their salary payment and service. On behalf of GB members Saiful Anam, Govt. Nominee, gave consent that all matters relating to teacher's appointment, confirmation, new admission with necessary fee-structure and other day-today works, etc. will be carried on by Pricipal in consultation with the President until the new GB will be formed. They will have approval in this regard. Any problemetic issue will be preferably
